Diploma in Teamwork and Personal Development in the Community

The table below is intended to help Combined Cadet Force CFAVs identify which areas of the CCF syllabus fit the BTEC as Recognised Prior Learning (RPL) – in other words, which BTEC Level 2 Unit requirements can be met if the learner has achieved the criteria under the ‘Practical element’ column. The learner does not need to have achieved these examples before enrolling.

Registration requirements

Residency and Nationality

- ESFA-funded qualifications must be delivered in England to a British Citizen or National of another EU country; and
- The organisation delivering the qualification must be based in England
- The learner must have been resident in the UK, Channel Islands, the Isle of Man, and Overseas British Forces Bases or within the European Union (EU) for the last three years (not just for education)
- CVQO receives limited funding for cadets from Scotland, Wales and Northern Ireland

Age

- The majority of cadets can be funded for this qualification if they are 16, 17 or 18 years of age on or before 31st August 2020. (Learners must have been born between 1 September 2001 and 31 August 2004 to be eligible in the academic year starting 1 August 2020)
- Speak to your CVQO Regional Manager or contact CVQO via www.cvqo.org to check eligibility and funding
- Learners have a maximum of two academic years to complete the qualification(s)
